#### III. TEACHING

At Ball State University I teach graduate courses for school psychology graduate students. Most of my courses are at the advanced doctoral student level. Courses I have taught include: psychological consultation theory and methods, academic assessment and intervention, supervision models in psychology, ethics, law and multicultural issues in professional psychology, evidence-based interventions in psychology, integrated advanced (externship) practicum in psychological services in school settings and advanced practicum in evidence-based interventions where students are placed in multiple types of settings (clinics, hospitals, schools, community mental health centers, residential treatment).
